


GENDER CRIMES ABSENT FROM POST-WII TRIBUNALS

GENDER CRIMES IN THE GENEVA CONVENTIONS AND PROTOCOLS

- Article 27 of the Fourth Geneva Convention: "Women shall be especially protected against any *attack on their* honor, in particular against rape, enforced prostitution, or any form of *indecent* assault."
- Common Article III of the Fourth Geneva Convention does not mention rape or sexual violence as a prohibited act,
 but instead protects "outrages upon personal dignity, in particular humiliating and degrading treatment."
- Article 76 of Additional Protocol to Geneva Convention: "Women shall be the object of special respect and shall be protected in particular against rape, forced prostitution, and any other form of indecent assault."


TRANSITIONING TO THE CODIFICATION OF GENDER CRIMES

- Yugoslav Wars International Criminal Tribunal for the Former Yugoslavia (ICTY)
- Rwandan Genocide International Criminal Tribunal for Rwanda (ICTR)
- The use of rape as an ethnic cleansing tool in the wars transitioned it from a private, inevitable "collateral of war" to a public, political "weapon of war."




GENDER CRIMES AS GENOCIDE

- Landmark case *Prosecutor v. Akayesu*
- Historic conviction of rape and sexual violence as acts of genocide
- Recognized rape as a form of torture and acknowledged that rape and sexual violence are the "worst ways of inflicting hard on the victim as he or she suffers both bodily and mental harm."



GENDER CRIMES AS CRIMES AGAINST HUMANITY AND WAR CRIMES

- Prosecutor v. Delalic:
 Acknowledged rape causes
 more than an "outrage upon dignity" it inflicts severe
 physical and psychological suffering
- Prosecutor v. Kunargc et al. and Prosecutor v. Furundzija: recognized rape and sexual assault as self-standing war crimes



STILL A LONG WAY TO GO ...

- 10 years after Rwandan genocide, the number of rape convictions is disturbingly low
- "The ICTR handed down 21 sentences: 18 convictions and 3 acquittals. An overwhelming 90% of these judgments contained no rape convictions. More disturbingly, there were double the number of acquittals for rape than there were rape convictions."
- Special Court of Sierra Leone: Civil Defense Forces Trial silencing the testimonies of women





STAGGERING STATISTICS

AUGUST 2014

- 10,000 Yazidis killed at start of ISIS invasion
- 6,400 Yazidis taken
 captive
- 450,000 Yazidis displaced
 in IDP camps

5 YEARS LATER...

- 12,000 Yazidis killed
- 3,000 still missing in captivity
- 350,000 Yazidis still
 displaced in IDP camps


